Who Is Liable for an Auto Accident Caused by Icy Roads?

Ice, snow and rain can make roadways slippery and increase the risk of an auto accident. Motorists driving during wintery weather must pay extra attention to their environment.

Unfortunately, even the most diligent drivers can quickly lose control of their cars if they hit a patch of black ice. Who is responsible for a car collision on icy roads?

Determining Who Is at Fault

Legally speaking, you cannot blame a car crash on the weather. All drivers must adequately maintain their vehicles and exercise extreme caution when they're behind the wheel during a snowstorm.

If you were involved in a wintertime car crash that was no fault of your own, you may be able to collect compensation. To do so, your attorney must prove the following components of the negligence of the potentially liable party:

- Duty of care
- CausationDamages
- Breach of duty

Car crash attorneys use evidence to establish negligence, including witness statements, accident scene pictures, vehicle damage and police reports. This evidence is even more beneficial for accident claims that involve multiple cars.

If you spot a scam, report it at **FTC.gov**/ **complaint**. You can also get the latest tips and advice from the FTC about scams sent right to your inbox. Sign up for these free scam alerts from the FTC at **www.FTC.gov/scams**. Here are nine ways to keep yourself safe.

Spot imposters. Scammers often pretend to be someone you trust. Don't send money or give out personal information in response to an unexpected request.

Do online searches. Type a company or product name into your favorite search engine with words like "review," "complaint" or "scam."

Don't believe your caller ID.

Technology makes it easy for scammers to fake caller ID information.

Don't pay upfront for a promise.

Someone might ask you to pay in advance for things like debt relief, credit and loan offers, mortgage assistance, or a job. They might even say you've won a prize, but first you have to pay taxes or fees.

Consider how you pay. Credit cards

have significant fraud protection built in, but some payment methods don't. Wiring money is risky because it's nearly impossible to get your money back. That's also true for reloadable cards and gift cards.

Talk to someone. Before you give up your money or personal information, talk to someone you trust. Slow down, check out the story, do an online search, consult an expert — or just tell a friend.

Hang up on robocalls. If you answer the phone and hear a recorded sales pitch, hang up and report it to the FTC. These calls are illegal.

Be skeptical about free trial offers.

Some companies use free trials to sign you up for products and bill you every month until you cancel.

Don't deposit a check and wire

money back. If a check you deposit turns out to be a fake, you're responsible for repaying the bank.

- They knew, or should have known, about the hazard and did nothing to fix it


What Should You Do After a Slip and Fall?

Gnocchi with Spinach and Chicken Sausage

Ingredients:

- 1 package 16 ounces potato gnocchi
- ▶ 2 tablespoons olive oil
- 1 package (12 ounces) fully cooked Italian chicken sausage links, halved and sliced
- ▶ 2 shallots, finely chopped
- ▶ 2 garlic cloves, minced
- ▶ 1 cup white wine or chicken broth
- ▶ 1 tablespoon cornstarch
- ▶ 1/2 cup reduced-sodium chicken broth
- 3 cups fresh baby spinach
- ▶ ¹⁄₂ cup heavy whipping cream
- ▶ ¼ cup shredded parmesan cheese

Instructions:

- Cook gnocchi according to package directions. Meanwhile, in a large skillet, heat oil over medium-high heat; cook sausage and shallots until sausage is browned and shallots are tender. Add garlic; cook 1 minute longer.
- 2. Stir in wine. Bring to a boil; cook until liquid is reduced by half, 3-4 minutes. In a small bowl, mix cornstarch and broth until smooth; stir into sausage mixture. Return to a boil, stirring constantly; cook and stir until thickened, 1-2 minutes. Add spinach and cream; cook and stir until spinach is wilted.
- 3. Drain gnocchi; add to pan and heat through. Sprinkle with cheese.

What You Need to Know About Camp LeJeune Claims (Including the Deadline)

Located in North Carolina, Camp LeJeune is the second largest US Marine base. The water supply at Camp LeJeune was found to be contaminated with dangerous toxins that may have led to cancers, infertility, other significant health issues, and even death. Those harmed by the toxic water include not only former Camp Lejeune soldiers and their families who lived or worked on the base, but also non-military staff, employees and neighbors in the areas surrounding the camp. In 2022, the PACT ACT (Promise to Address Comprehensive Toxics) was enacted and included The Camp Lejeune Justice Act of 2022, which allows anyone who lived or worked on the base between 1953 and 1987 to file a claim and lawsuit for damages.

There are some important things to know about this litigation:

- Water contamination affected not only Camp LeJeune, but also New River Air Station, which shares the water supply. Anyone residing at either location may participate in the lawsuit.
- A claim for damages under the PACT Act is not the same as a claim for serviceconnected disability benefits that are available for Veterans through the Department of Veterans Affairs. The claim form in this litigation must be submitted to the Department of Navy on a special form.
- Claims can be filed not only by Veterans and their families, but also civilians that lived and worked on either base for at least 30 days from 1953-1987. This includes children that were in utero or born after exposure to the toxic water.
- ▶ The deadline for claims is August 10, 2024.
